

FROM THE DESK OF TERRY BEECH

Dear Friends and Neighbours,

I got into politics to make a difference for our community. When I first started knocking on doors, I promised that I would be the hardest-working M.P. in the country. Over the past nine years, I have done everything possible to deliver on that promise. I've replied to and acted on over 20,000 surveys while breaking records nationally for the most door knocks and phone calls. In 2023, I was recognized as the hardest-working constituency M.P. in Canada, and in 2024, I was the first M.P. to be recognized with that distinction two years in a row. Everyone in our community who asks for a face-to-face meeting with me gets one, and I've kept that promise for more than a decade. My girls, Nova and Solar, keep me more motivated than ever to continue working with our community to deliver results for Burnaby, the District of North Vancouver and Canada.

I've approached politics differently, placed partisanship aside and worked hard to build strong relationships with community members, leaders, and elected officials from all parties and all levels of government so that our community has a loud voice and gets things accomplished. I've focused on making life more affordable, improving healthcare, and fighting climate change while growing our economy. As a G7 nation, we have the lowest deficit, lowest net debt to GDP ratio, and the best foundation for economic growth. We maintained that fiscal advantage while increasing pension benefits and healthcare transfers and launching programs like childcare, dental care, and pharmacare. These programs increase economic growth while lowering costs for local families.

Since becoming a Minister, I have focused on improving services while reducing the size and cost of government. Digitalization of government services means that you can access the services you need without standing in line or taking time off work. These improvements also significantly reduce the marginal cost of service provision.

We need this work to continue. This session of parliament is a crucial point in Canada's history, and we need to make an important choice about the future of our country. I am working on your behalf every day to create a more sustainable, affordable, and competitive future for Burnaby, North Vancouver and Canada.

Housing

For over 30 years, the federal government had been absent from investing in housing. Today, individuals are moving into new affordable units every day nationwide. We have aligned our efforts with municipalities, provinces, and Indigenous Nations to build supply. When we launched the National Housing Strategy, we knew we were taking on one of our country's most challenging economic and social problems. We must continue building infrastructure so everyone can access an affordable home.

Economy & Jobs

Growing our economy builds opportunities for our local families and future generations. This includes ensuring that the appropriate infrastructure is in place so that our local small and large businesses are in a position to succeed. Canada has the best trading access of any nation in the world, and we are making smart investments in industries and technologies that produce high-value and good-paying jobs. Investments in cleantech, energy, film, artificial intelligence, and more ensure that our riding is on the cutting edge of innovation.

Traffic & Transit

Our investments in Skytrains, Seabus, electric buses, highways, bridges, and other infrastructure ensure our economy can grow while reducing your commute. We are also ensuring that the housing supply is increasing around transit hubs while also being streamlined, accessible, and cost-efficient.

Health

In addition to our first health accord, we've committed a historic \$200 billion to ensure the provinces and territories have the resources to provide the quality health care we all deserve. Unlike previous agreements, this funding is tied to reporting on the use of the funds and health outcomes. Too often, money dedicated to health has been used for other purposes, but now there is a mechanism to promote innovation, transparency, and best practices between the provinces and territories. Additionally, diabetes medication and contraceptives will be universally provided. We will continue to expand this program, focusing on those areas that pay for themselves first. These initiatives save our healthcare system billions of dollars in the long term while supporting Canadians' overall health.

Climate Change and the Environment

Governments have put off fighting climate change for too long, and now we must consolidate our efforts to catch up. You may have heard a misleading slogan that we need to "Axe the Tax." The federal carbon price is revenue-neutral and does not apply in B.C. The federal program returns more money to 8 out of 10 families than they pay and works as an affordability program. This return especially benefits low-income families. The cost of climate change is real, and we've worked hard to implement a world-leading plan that works while creating historic economic opportunities. Our plan is good for the planet, our community and the economy, and we must continue implementing it with vigour.

Affordability & Fiscal Responsibility

Global inflation and increasing costs have been challenging for Burnaby and North Vancouver families. We've worked hard to reduce poverty levels and invest in our future, all while keeping our fiscal framework in check. Canada has the lowest deficit amongst our peer economies and the highest forecasted economic growth. That's why wages have outpaced inflation for 18 straight months, why inflation is now at 2%, and why interest rates are declining so quickly. This allows us to cut taxes for the middle class and small businesses while investing in programs that make life more affordable including:

The Canada Child Benefit

This program supports 9 out of 10 families in our community and has lifted over 650,000 children out of poverty. Just last year, more than \$43.3 million in Canada Child Benefit payments were administered to over 8400 families in Burnaby and North Shore, putting an average of \$5000 annually back into the pockets of families.

\$10-A-Day Child Care

This initiative is a quadruple win: it grows our economy, gets parents back in the workforce, supports children's early learning, and makes life more affordable. In addition, tens of thousands of new childcare spaces are underway.

Canada Dental Care Plan

Our government's Canada Dental Care Plan (CDCP) is making dental care accessible and affordable. Over 750,000 Canadians have received dental care, including thousands of seniors and young children in our community. Many of whom are sitting in a dental chair for the first time. More than 80% of active oral health providers are participating in the program and are delivering the essential care that Canadians need.

National School Food Program

400,000 children will benefit from nutritious meals, leading to smarter kids and better long-term outcomes. Parents will enjoy the benefit of spending less time on meal prep and knowing that their children are well nourished, all while saving the average family \$800 annually.

Groceries

We are modernizing the Competition Act to protect consumers and lower grocery prices. This reform targets price competition and works alongside the Grocery Task Force, Food Price Data Hub, and Grocery Benefit to make food more affordable. We also eliminated non-compete clauses in new and existing leases, allowing new entrants to compete in Canada at scale for the first time in generations.
